Caste/ Tribe certification should be enclosed with the application by the tribal. etc., Now Tribal applicants should furnish valid trading license from concerned District Authorities alongwith the application. 2 (two) copies of attested photographs of the applicants, Labour License issued by the labour Commissioner Meghalaya, Shillong. Financial sound certificate and security money to be deposited for Fresh Registration should be enclosed with the applications.
