Application are invited from the unmarried candidates who are permanent resident of Meghalaya for admission to the Certificate Training Course in Handloom Technology at Handloom Training Institute, Mendipathar North Garo Hills for the Session 2012 – 13 for self employment.

**Terms & Condition are as follows**

1. **Duration:** The duration of the course is 2 years commencing from 1 – 11 – 2012.
2. **Age Limit:** Applicants should not be less than 15 years and not more than 21 years as on 1 – 1 – 2012. In case of SC/ST the maximum age limit is 23 years which will be based according to SSLC Admit card.
3. **Qualification:** Applicants must have passed Matriculation with Science and Math as compulsory and must have been secured 45% and above in Aggregate and below 45% need not to apply.
4. **Permanent Residential:** Non – tribal applicants should submit PRC (Permanent Residential Certificate) issued by the Deputy Commissioner District of their respective District without which application will be summarily rejected.
5. **Selection:** The Selection of the Candidates will be based on qualifying marks in SSLC and oral interview.
