The Zonal Officer Sericulture, Shillong/ Tura/ District Sericulture Officer, Shillong/ Nongpoh/ Nongstoin/ Jowai/ Tura/ Williamnagar/ i/c Bagmara and Sericulture Development Officer, Resubelpara/Tikrikilla with a validity upto 31st March, 2012. The rate should be inclusive of all Taxes. The successful Quotationers/Suppliers will have to supply the materials at these place or as directed by the concerned D.D.O. within one month from the date of issue of Supply order failing which the Supply order will be treated as cancelled and the earnest money will be forfeited to the Government.
2. The undersigned reserve the right to reject any one or all quotation with assigning any reason and does not bind himself to accept or recommend acceptance at lowest rates of any quotation.
3. Tender must be accompanied by:

 - c. Attested copies of valid and current Central Sale Tax Certificate from the concerned Superintendent of Taxes.
 - d. Attested copies of SC/ST Certificate issued by the concerned Competent Authority (for Tribal Tenders).
 - e. Attested copies of valid Trading License in terms of KHADC, JHADC and GHADC (for - non Tribal) Regulation Act. 1954 by Tenderers who are required to obtain such License.
